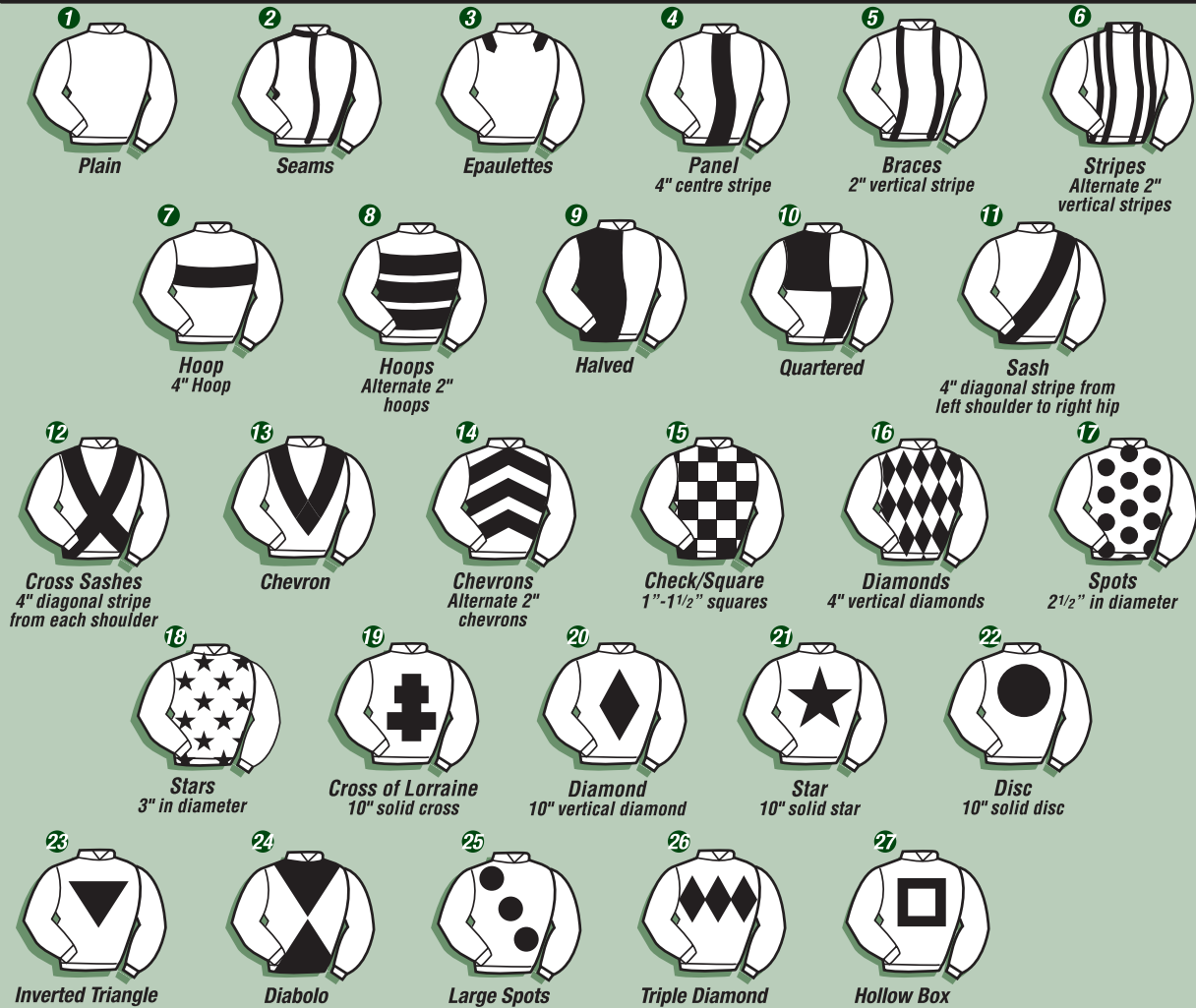

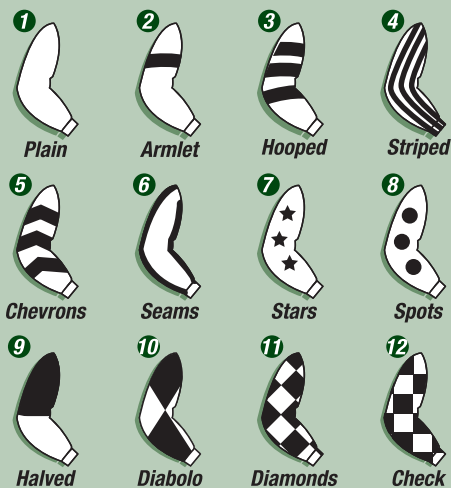

Jackets: - Identical front & back

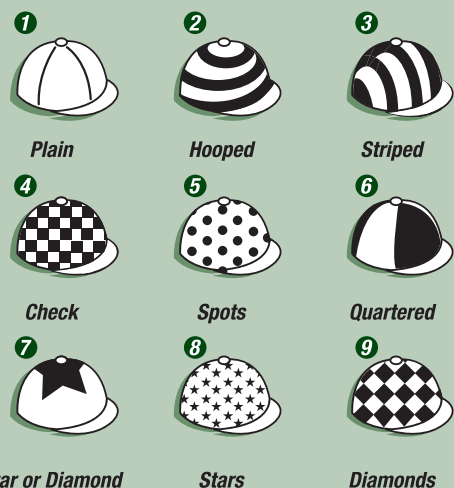


Sleeves:

- Avail of discounts on a range of services and other occasional racecourse packages
